**ORDER**

WHEREAS, in terms of section 14(3)(a) of the NCTE Act 1993, WRC granted recognition to **VISHWASHANTI GURUKUL TEACHERS TRAINING ACADEMY B.ED. COLLEGE, (ENGLISH MEDIUM) RAJBUG, LONI KALBHOR, TAL.- HAVELI, PUNE, MAHARASHTRA** for B.Ed. (E) (Co-Ed) course vide order dated 07.01.2008 for an annual intake of 100 seats.

2. AND WHEREAS, WRC issued Revised Recognition Order to VISHWASHANTI GURUKUL TEACHER TRAINING ACADEMY, B.ED COLLEGE, RAJBUG, LONI, KALBHOR, TAL HAVELI, DISTT PUNE – MAHARASHTRA vide order dated **03.08.2015** for conducting B.Ed. course of two year duration with an annual intake of 100 students (Two basic units of 50 students each) from the academic session 2015-2016.

3. AND WHEREAS, the institution has request for Change of University and applied for change of Name of the institution vide letter received in WRC on 29.11.2019.

4. AND WHEREAS, the matter was placed in 313<sup>th</sup> and 314<sup>th</sup> meeting of WRC held on 25<sup>th</sup>-27<sup>th</sup> February 2020 and July 13<sup>th</sup>-15<sup>th</sup>, & 22<sup>nd</sup> 2020 the Committee decided as under:-

*The Committee considered the matter and observed as under:-*

- (i) *The proposed university has been gazette notified in the State of Maharashtra.*
- (ii) *The existing institution Vishwashanti Gurukul Teacher Training Academy B.Ed. College is presently recognised by NCTE vide Recognition Order No. WRC/5-6/100<sup>th</sup> /2007/25680 dated 07/01/2008 and revised order dated 03/08/2015.*
- (iii) *The institution has submitted NOC from the previous and proposed university.*
- (iv) *The land documents and sponsoring Trust/Society of the previous institution and proposed university are same.*

*In view of the above the Committee decided to allow the following from the date of Gazette Notification of the proposed university by Govt. of Maharashtra –*

- (i) *The name of the existing institution be changed from Vishwashanti Gurukul Teacher Training Academy B.Ed. College to School of Education & Research, MIT Art, Design and Technology University.*
- (ii) *The affiliating University be changed from existing Savitribai Phule University, Pune to MIT Art, Design and Technology University, Pune, MS.*

NOW, THEREFORE, as per the decision of WRC the permission is hereby granted for change of Name of institution from VISHWASHANTI GURUKUL TEACHER TRAINING ACADEMYC B.ED COLLEGE, RAJBUG, LONI, KALBHOR, TAL HAVELI, PUNE to **SCHOOL OF EDUCATION AND RESEARCH, MIT ART, DESIGN AND TECHNOLOGY UNIVERSITY, MAHARASHTRA** and change of affiliating body from SAVITRIBAI PHULE UNIVERSITY, PUNE MAHARASHTRA for its B.ED. course to **MIT ART, DESIGN AND TECHNOLOGY UNIVERSITY, PUNE, MAHARASHTRA**
